From the Desk of our State Chaplain...

Currently, I am that pastor of Our Lady of Sorrows parish (and her 23 missions!) in Las Vegas (yes, a Raton Tiger among the West Las Vegas Dons and Robertson Cardinals – heaven help me!). I have been blessed to be in Vegas for the last three years, after spending my first two years of ordained ministry at the Cathedral Basilica of St. Francis of Assisi and Christo Rey parishes in Santa Fe. I am what's called a 'late vocation;' I was ordained at the age of 46 after spending most of my post-college career working for New Mexico State Parks. It was a great job to have being able to spend so much time outdoors in such places as the Rio Grande bosque in Albuquerque, Heron Lake and Navajo Lake, among others. God used my love of nature and the outdoors to start bugging me about a different path in life, and while I was living in Tucson, AZ, a good friend and brother in Christ (and now a permanent deacon in the Archdiocese of Seattle) started the conversation. I resisted at first, and for several years thereafter, but the Hound of Heaven (who's really a pesky Chihuahua that constantly nips at your heels) finally won out. Now, 10 years into the adventure that started in August 2015, at seminary in Connecticut, I wonder why I resisted for so long. God be praised!

Not that it hasn't had challenging periods, like our current battle with COVID-19. While I don't know anyone personally who has contracted the virus, I know plenty who are suffering from the strains of loneliness, isolation, financial struggle, and the overall upheaval this pandemic has caused in our "normal" lives. We struggle to carve out a new, and hopefully temporary, normal, but it has worn so many of us down. But this isn't the first go-round for the People of God – think of the Spanish flu pandemic of 1918-20, WWI and WWII, and prior significant trials that battered the Church before. Yet, She still stands firm, and beckons the people of God, like St. Peter, to step out of the boat and onto the stormy seas, to walk toward Jesus who stretches out His hand to catch us. In those moments when the wind and waves of fear, anxiety, doubt, and frustration, make us sink, let us keep our eyes on Jesus who calms the storms and guides us daily (if we let Him) to our eternal home in heaven.


